## Membership Categorization

Prospective partners must complete the technical training requirements and need to exhibit the following capabilities:

- Demonstrate the necessary technical, accounting product, and sales knowledge to sell and support AddonSoftware products
- Sell and install AddonSoftware to at least three new customer or virtual sites per year
- Submit annual marketing plan detailing product and sales goals for AddonSoftware's review and acceptance

## Annual Membership Fee

Partners may join at the Authorized Partner level without paying any fees. Premier and Elite Partners pay the fees on a monthly or an annual schedule, whichever is most convenient. Fees are \$600 per month or discounted to \$6,600 per year. Participation in the Co-operative Development Program, as described below, reduces the membership fee to \$300 per month or \$3,300 per year.

## Co-operative Development Program

The benefits of participating in the Co-operative Development Program are available to all Partners. Premier and Elite Partner participation is included in their membership fee. Recurring 4-hour monthly minimum contributions for 12 consecutive months reduces the following year's fee to \$3,300. Development activities exceeding 4 hours per month results in new product or rental sales credit at the retail rate of \$150/hour. Co-op credits can only be used to purchase products for an end-user customer that the AddonSoftware Partner is supporting directly and are not transferable.

Authorized Partners can optionally enroll in the Co-operative Development program by paying a membership fee of \$300 per month or a discounted \$3,300 per year. Development activities exceeding 4 hours per month results in new product or rental sales credit at the retail rate of \$150/hour.
